

Camelot Woods Website Privacy Policy

Lancelot Homeowners Association (HOA) is committed to protecting the privacy of members of the HOA, Please read the following privacy policy to learn more about our information and dissemination practices for the Camelot Woods website (the site).

Scope

This policy covers how the HOA treats personal information collected and received through the site. Personal information is information about the owners that may be used to personally identify the user, such as names, addresses, email addresses, or phone numbers, and that is not otherwise publicly available.

Information Collection

To use all the features and services available through the site, owners must supply registration information. The HOA requests certain personally identifiable information be provided about you and the other users of your account, such as names, addresses, email addresses, and phone numbers. Users also have unique identifiers (such as username and password) so the HOA can provide information to all owners on the site.

Information Use

The HOA may use personal information to communicate with you about activities and events and provide general information concerning the community. Occasionally, we may need to send service-related announcements; for example, if the site is scheduled to be unavailable temporarily for maintenance, the HOA may send you an email to let you know.

Sharing of Information

The HOA shall not rent, sell or share the information about a user with any other company, other than a duly retained management company, except when we have your permission or under the following circumstances.

Community Directory: Unless the user otherwise instructs the HOA, the HOA will include the same personal information in the website's directory as provided to the printed phone directory of the community. The user may notify the HOA or the Site Administrator if the user wishes to exclude any or all personal information.

Legal Disclosures: The HOA reserves the right to disclose personal information in order to comply with a court order, subpoena or other legal process, or to exercise our legal rights or defend against legal claims.

Links

This privacy policy applies solely to information collected through your access to and use of this site. However, this site may contain links to other web sites owned and operated by third parties. Please be aware that the HOA is not responsible for the information gathering and dissemination practices of such other sites; and this privacy policy does not apply to such other sites. When you leave this site, The HOA encourages the user to read the privacy statements of every web site that collects personally identifiable information about the user.

Surveys, Contests or Polls

From time to time the HOA may request additional information via surveys or polls. Participation in these surveys or polls is completely voluntary; therefore, the user has a choice whether or not to participate in the survey or poll and to disclose this information. The requested information will typically include contact information (such as name and address).

Security

The HOA takes every reasonable precaution to ensure that the transmission and storage of personal information is secure. The HOA limits access to personal information about user to approved residents and agents the HOA believes has a need to have that information in order to host, manage, operate and support the Site and the community.

Correcting/Updating/Deleting/Deactivating Personal Information

If the user's personally identifiable information (such as phone number, email or postal address) is incorrect or if user no longer desires to access or use the Site, user may correct the information or inactivate an account by contacting the Site Administrator.

Notification of Changes

If the HOA decides to change this privacy policy, the HOA will post those changes to this privacy policy, the website and other places deemed to be appropriate so user may always be aware of the information collected, how it is used, and under what circumstances. The HOA may also email users notifying them of the changes in the privacy policy. Users should check the site periodically for changes to this privacy policy. Any changes to this privacy policy shall be effective immediately upon posting. If any change to this privacy policy is unacceptable to you, your only recourse is to terminate your use of this Site.
